A Bidder desirous of taking part in e-tender/quotation invited by The Chairperson, Haldibari Municipality will login to the e Procurement portal of the Government of West Bengal from the website:http://wbtenders.gov.in directly with the help of their Digital Signature Certificate.

**B.**He will select the tender to bid and initiate payment of pre- defined EMD/Tender fees for that tender by selecting from either of the following payment modes:

(i) Net Banking (any of the listed bank in the ICICI Bank payment Gateway) in case of payment through ICICI Bank Payment Gateway

(ii) RTGS/NEFT is case of offline payment through bank account in any bank.

## **Payment Procedure:**

(a) Payment by Net Banking (any listed bank) through ICICI Bank Payment gateway :

(i) On selection of net banking as the payment mode, the bidder will be directed to ICICI Bank Payment Gateway webpage (along with a string containing a Unique ID) where he will select the Bank through which he wants to do the transaction.

(ii) Bidder will make the payment after entering his Unique ID and password of the bank to process the transaction.(iii) Bidder will receive a confirmation message regarding success/failure of the transaction.

(iv) If the transaction is successful, the amount paid by the bidder will get credited in the respective Pooling account of the State Government Office/PSU/Autonomous Body/Local Body/PRIs, etc. maintained with the Focal Point Branch of ICICI Bank at R.N. ## Refund / settlement process of EMD:

**i.** After opening of the bids and technical evaluation of the same by the tender inviting authority through electronic processing in the e-procurement portal of the State Government, the tender inviting authority will declare the portal of bids as successful or unsuccessful which will be made available, along with the details of the unsuccessful bidders, to ICICI Bank by the e-procurement portal through web services.

ii. On receipt of the information from the e-Procurement portal, the Bank will refund, through an automated process, the EMD of the bidders disqualified at the technical evaluation to the respective bidders" bank accounts from which they made the payment transaction. iii. Once the financial bid evaluation is electronically processed in the e-procurement portal, EMD of the technically qualified bidders other than that of the L<sub>1</sub> and L<sub>2</sub> bidders will be refunded, through an automated process, to the respective bidders" bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on rejection of financial bid is uploaded to the e-procurement portal by the tender inviting authority. vii. #### 6)Date and Time Schedule:

7) The Prospective Bidder shall have to execute the work in such a manner so that appropriate service level of the work is maintained during progress of work and a period of 1 (one) year from the date of successful completion of the work to the entire satisfaction of the Authority. If any defect / damage is found during the period as mentioned above, the contractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so, penal action against the contractor will be imposed by the Department as deem fit. The contractor may quote his rate considering the above aspect. #### 5) SPECIAL TERMS & CONDITIONS AND SPECIFICATION OF WORKS

\*\* In order to ensure Sustainability to the created assets, particularly to the roads within the Municipal Areas, The Defect Liability during the period of 3 years is being incorporated.

a) The tenderer should quote his base offer as per the quantity described in the Schedule, which may be

accepted by the department if found technically acceptable and economically viable.

If any tenderer withdraws his tender within the validity of tender period without giving any satisfactory explanation for such withdrawal, he shall be disqualified for participation in any tender to this Municipality for minimum period of one year.

The earnest money will be forfeited if a tenderer resorts to any unethical activity, canvassing and / or withdraws his offer before expiry of the tender validity.

#### Opening & evaluation of tender:

#### **Opening of Technical Proposal**:

Technical proposals will be opened by the Concerned Tender Inviting Authority or his authorized representative electronically from the website using their Digital Signature Certificate (DSC).

Intending Tenderers may remain present if they so desire.

#### 1. Financial Proposal

#### Penalty for suppression / distortion of facts:

If any tenderer fails to produce the original hard copies of the documents like Completion Certificates and any other documents on demand of the Tender Evaluation Committee within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies, it may be treated as submission of false documents by the tenderer and action may be referred to the appropriate authority for prosecution as per relevant IT Act.

#### **Rejection of Bid:**
