A Bidder desirous of taking part in e-tender/quotation invited by The Chairperson, Haldibari Municipality will login to the e Procurement portal of the Government of West Bengal from the website: <u>http://wbtenders.gov.in</u> directly with the help of their Digital Signature Certificate.

B. He will select the tender to bid and initiate payment of pre- defined EMD/Tender fees for that tender by selecting from either of the following payment modes:

(i) Net Banking (any of the listed bank in the ICICI Bank payment Gateway) in case of payment through ICICI Bank Payment Gateway

(ii) RTGS/NEFT is case of offline payment through bank account in any bank.

Payment Procedure:

(a) Payment by Net Banking (any listed bank) through ICICI Bank Payment gateway:

5) SPECIAL TERMS & CONDITIONS AND SPECIFICATION OF WORKS:

** In order to ensure Sustainability to the created assets, particularly to the roads within the Municipal Areas, The Defect Liability during the period of 3 years is being incorporated.

** The Security Period for the Security Deposit/EMD is 3 year.

a) The tenderer should quote his base offer as per the quantity described in the Schedule, which may be accepted by the department if found technically acceptable and economically viable.
